Ryan Dempsey Argentieri serves as the deputy director of the Office of Technology at ONC. In this position, she supports ONC's Certification & Testing, Standards, and Technical Strategy & Analysis portfolios. She also leads the coordination of cross-functional programs promoting interoperability and standards harmonization for high priority areas such as public health data modernization and social determinants of health. Before joining ONC, Ryan was Principal of Silver Mountain Solutions, a global advisory firm focused on the launch of new products and initiatives in cleantech, infrastructure and

health information technology, as well as public-private partnerships, focused on environmental preparedness and economic resiliency. Ryan has worked as a founder, co-founder and advisor to more than a dozen start-ups and has a specialization in building public private partnerships in health care and within the built environment. She started her career at United Technologies corporation (now Raytheon Technologies) where she managed both the U.S. and international government relations across the commercial and aerospace/defense portfolio before moving on to lead the company's integrated building and district level energy solutions work in emerging markets. Ryan holds a master's degree in Business Administration from Johns Hopkins University's Carey School of Business, a master's degree in Arts in Conflict Resolution, International Relations and Human Rights from the Joan B. Sarah C. DeSilvey balances practice as a rural family nurse practitioner with advocacy for addressing the social determinants of health in clinical and community practice. Her area of focus is developing the terminology to capture the process of caring for patients' social needs. Over the last decade she has collaborated with diverse colleagues on medical and social care integration and interoperability projects. Her work has now evolved into Gravity Project – a national consensus initiative to develop the data and data standards to address social needs. She serves as the Terminology Director helping to weave the

practice of social care, community-based approaches, and the literature of social risk into health care terminology. In line with her focus on social care terminology, she was Secretary of the Department of Health and Human Services Xavier Becerra's 2023 selection for the US Health Information Technical Advisory Committee (HITAC) and currently co-chairs the HITAC Interoperability Standards Workgroup.





Bradley Malin, PhD

Dr. Bradley Malin is the Accenture Professor of Biomedical Informatics, Biostatistics, and Computer Science, as well as Vice Chair for Research Affairs in the Department of Biomedical Informatics. His research is funded through grants from the National Science Foundation (NSF), National Institutes of Health (NIH), and Patient Centered Outcomes Research Institute (PCORI). His research is on the development of technologies to enable artificial intelligence and machine learning (AI/ML) in the context of organizational, political, and health information architectures. He has made specific contributions in several areas,

including distributed data processing methods for medical record linkage and predictive modeling, intelligent auditing technologies to protect electronic medical records from misuse in the context of primary care, and algorithms to formally anonymize patient information disseminated for secondary research purposes. His investigations on the empirical risks to health information reidentification have been cited by the Federal Trade Commission in the Federal Register and certain privacy enhancing technologies he developed have been featured in popular media outlets and blogs, including Nature News, Scientific American, and Wired magazine. Dr. Malin completed his education at Carnegie Mellon University, where he received a bachelor's in biological sciences, a master's in machine learning, a master's in public policy and management, and a doctorate in computer science (with a focus on databases and software systems).

Her work involves Health IT regulation and policy development, as well as policy coordination and advisement across HHS operating divisions. Prior to her work at HHS, Ms. Onwunli was a Senior Analyst at the Medicaid and CHIP Payment and Access Commission (MACPAC) a non-partisan legislative branch agency that provides policy and data analysis and makes recommendations to Congress, the Secretary

of HHS, and the states on issues affecting Medicaid and the State Children's Health Insurance Program (CHIP). Before moving to Washington D.C., she was a Medicaid expenditure analyst with Florida's Agency for Health Care Administration where she worked on implementing the state's Long-Term Care Managed Care program and evaluating Florida's long-term care waivers.
