Questions for Animal Health and Veterinary Industry

The Reagan-Udall Foundation for the FDA has convened an Expert Panel to identify areas of opportunities and challenges facing the animal production, animal health and veterinary industries and provide recommendations for a holistic approach to solutions or paths forward. The Expert Panel conducting this work welcomes your input.

For example, you might consider the safety, quality and availability of animal food/feed, or the efficiency of feed conversion into animal growth sustainability of food/feed ingredients and animal production.
